**VIRGINIA BAR EXAMINATION
DECLARATION, AUTHORIZATION and RELEASE**

I, _____ hereby affirm that:

1. I am the applicant named in the foregoing application for admission to practice law in Virginia;
2. I have read the Rules of the Virginia Board of Bar Examiners (Board) relating to admission to practice law in Virginia, and I make this application in accordance with those Rules;
3. I understand that my obligation to furnish complete and accurate information in connection with this application is a continuing one, and accordingly, should anything occur or be discovered between the time this application is submitted and the time I am admitted that would change or render incomplete any portion of the information furnished in or in connection with this application, I will promptly notify the Board and furnish the necessary information to correct or complete my application;
4. I agree to give any further information which may be required in reference to my past record;
5. I hereby authorize the Board, their agents or authorized representatives, to make a complete investigation of my character, financial responsibility and general fitness to practice law in Virginia and to disclose such information about me as may be reasonably necessary to conduct such an investigation;
6. I hereby authorize and request every person, firm, corporation, association, and agency having control of any documents, records, or other writing, or having other information pertaining to me, to furnish to the Board any such writings and information the Board believes will relate to my moral character and/or fitness to engage in the practice of law, and to permit the Board and any of its agents or representatives to inspect and make copies of such documents, records and other writings;

I hereby release, discharge and exonerate the Board, their members, agents and representatives and any person, entity furnishing documents, records or information in connection with this application or the investigation discussed above from any and all liability of every nature and kind arising from any investigation or out of the furnishing, inspection or use of such documents, records and other information; and
8. Notwithstanding anything to the contrary herein, I hereby authorize the Board to release my name and Virginia Bar Exam data, including pass/fail information, to my law school(s) and to the National Conference of Bar Examiners.
9. I fully realize that the determination of whether I may be allowed to practice law in Virginia depends on the truth and completeness of my answers in this application and the information furnished with it;
10. If I choose to take the exam using a computer, I acknowledge there is some risk. The risks include but are not limited to equipment failure, software problems and electrical problems. I agree to assume all risk associated with use of a computer and acknowledge that I will have to handwrite the exam in the event of any problems;
11. Agree that the foregoing shall remain in effect for any future application that I may make to the Board.
12. I have read the foregoing application and the answers that I have given in it are true and complete.
