- True 2.6** I am not currently subject to lawyer discipline or the subject of a pending disciplinary matter.
- YES 2.7** I am the dependent spouse of an active duty service member of the United States Uniformed Services as defined by the Department of Defense (or, for the Coast Guard when it is not operating as a service in the Navy, by the Department of Homeland Security) and that my service member spouse is on military orders stationed in the Commonwealth of Virginia or the National Capitol region, as defined by the Department of Defense.

- YES** 4.3 As proof of my being a member in good standing in all jurisdictions where I have ever been admitted, I attach an original Certificate of Good Standing, dated within 90 calendar days prior to submission, from the court of last resort for each such jurisdiction.
- YES** 4.4 As proof of my disciplinary status in all jurisdictions where I have ever been licensed, I attached an original Certificate of Discipline, dated within 90 calendar days prior to submission, from the disciplinary authority that handles complaints against lawyers. Such certificate must provide all relevant information, reports, findings, documents and correspondence of any kind concerning my performance as a lawyer.

Please note: After receipt of the Local Counsel Affidavit, the Virginia State Bar will notify the Board of Bar Examiners that your Local Counsel is a member in good standing and meets the requirements to become your Local Counsel supervisor.
- YES 4.11** I will submit a **cashier's check, certified check or money order** made payable to "Virginia Board of Bar Examiners" in the amount of \$400. **No personal, firm or company checks accepted.** This filing fee covers the cost of processing the application, preparation of the Character Report and investigation of matters contained in the completed Character Report. I understand that this filing fee is **non-refundable** and that it is my responsibility to determine that I have satisfied all threshold requirements before submitting my application. In the event my application for a Military Spouse Provisional Admission in Virginia is denied and I decide to sit for the Virginia Bar Examination, I acknowledge that I must submit a separate bar exam application and pay the appropriate filing fees.
