I hereby release, discharge and exonerate the Board, their members, agents and representatives and any person, entity furnishing documents, records or information in connection with this application or the investigation discussed above from any and all liability of every nature and kind arising from any investigation or out of the furnishing, inspection or use of such documents, records and other information;
8. I fully realize that the determination of whether I may be allowed to practice law in Virginia depends on the truth and completeness of my answers in this application and the information furnished with it; and
9. I have read the foregoing application and the answers that I have given in it are true and complete.
