APPLICATION FOR EXAMINATION

I, **Jane Smith Doe**, hereby apply to the Virginia Board of Bar Examiners for permission to sit for the **February 2022** Virginia Bar Examination and for a license to practice law in the Commonwealth of Virginia in conformity with the Rules of the Board and the laws of the Commonwealth of Virginia.

YES I am applying as a **New Applicant - Option 3** for the **February 2022** Virginia Bar Exam. I am an attorney licensed to practice law and in good standing in **New York**, having achieved a passing score in **New York** on the **February 2019** bar exam, and I will sit for the Virginia Essay exam only. A passing score for Option 3 is solely based on the raw points awarded on the essays. A minimum score of 64 raw points is passing.

Section 1 - Personal Information

- YES 6.1 I understand that if all questions contained in this application are not answered fully and completely on its initial submission, the application may not be timely filed.
- YES 6.2 I understand that until I am licensed, admitted and registered as a member of the Virginia State Bar, I have a continuing duty to report immediately any change to my personal, educational or professional status, including anything that would modify any of my responses.
- 6.3 The filing deadline for the **FEBRUARY EXAMINATION** is on or before **THE PRECEDING 15th OF DECEMBER**; and the filing deadline for the **JULY EXAMINATION** is on or before **THE PRECEDING 10th OF MAY**, and
- YES (A) I understand that if my application is not actually **received** in the Secretary's office by the filing deadline, it may be deemed to be timely filed only if it has been transmitted expense prepaid to the Office of the Secretary of the Board by **Priority, Express, Registered or Certified** mail via the United States Postal Service, or by a third party commercial carrier for **Next-Day Delivery**, **and** the **official receipt** therefor issued by the United States Postal Service or by such third party commercial carrier, which shall be exhibited on demand of the Secretary, shows such transmission or mailing to the Secretary's office on or before the prescribed deadline.
- YES (B) I understand that **Priority, Express, Registered or Certified** mail via the United States Postal Service or **Next-Day Delivery** by a third party commercial carrier are the **ONLY** methods of transmission or mailing authorized by the statute. Laptop registration begins the second Wednesday of January for the February exam and the second Wednesday of June for the July exam. The initial registration period extends for 10 days. Late registration, with increased fee, extends until the last day of the month such registration began. If I do not register in the time period allowed, I will be required to handwrite the bar exam.

- YES 6.5** I acknowledge that the Board posts the most current pertinent information regarding the upcoming bar exam on its website, and that I should check the website regularly to ensure I have up-to-date and accurate information.
- YES 6.6** In order to maintain certification by the American Bar Association (ABA), law schools are required to report certain bar exam statistics regarding their graduates. Accordingly, I acknowledge that the Board will provide my name and applicant status (first time or repeat taker) and my pass/fail results to my law school.
